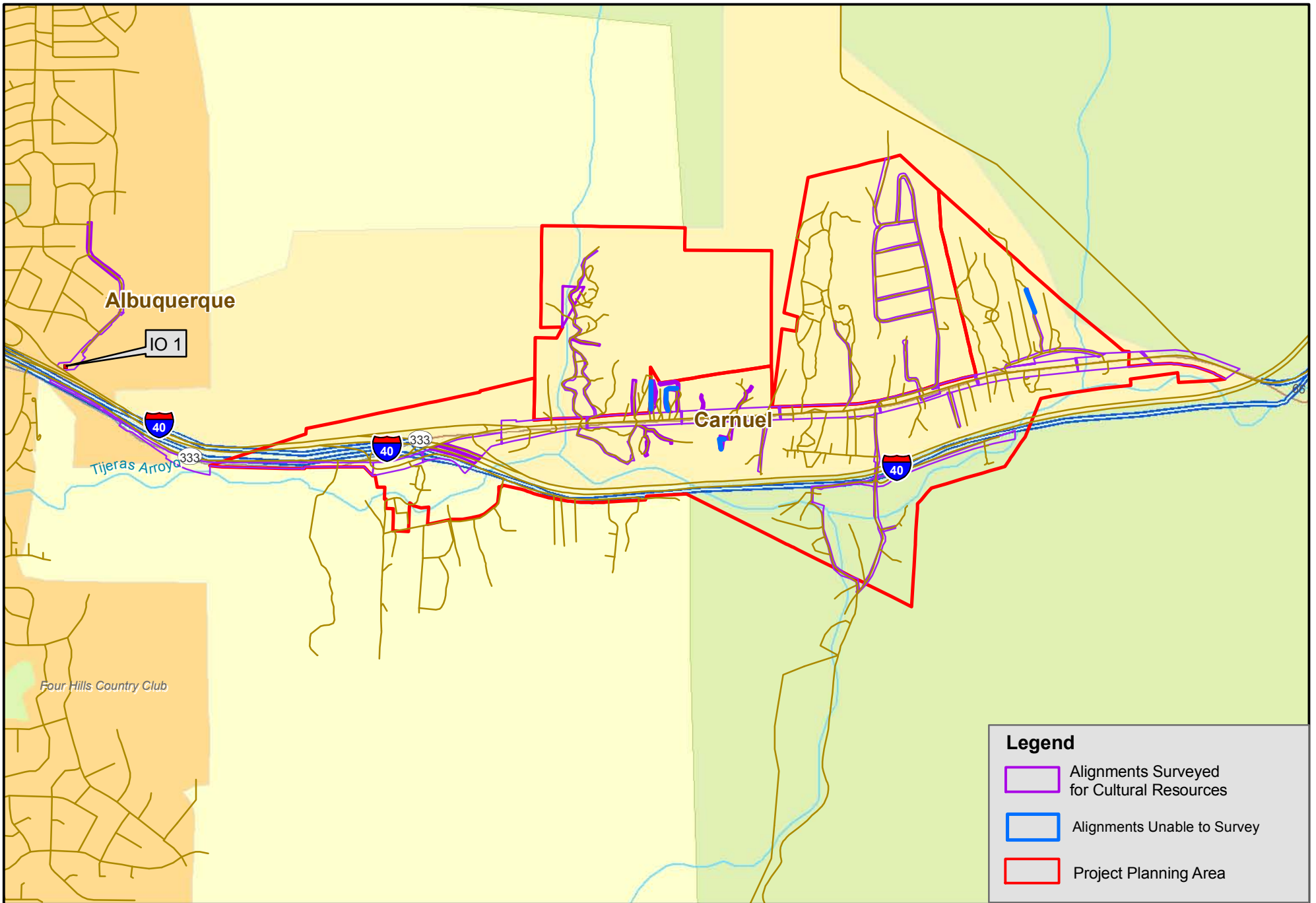

- Project Planning Area

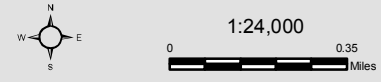

CULTURAL RESOURCE MANAGEMENT

Marron conducted a site file search and an intensive, 100 percent cultural resource survey for the various alternatives for water line improvements in Carnuel, Bernalillo County, New Mexico. Fifty-three historic buildings and one isolated occurrence were recorded. The isolated occurrence was thoroughly recorded and no further treatment is recommended. Below is a list of the historic buildings, their NRHP eligibility recommendations, eligibility recommendations as contributing to an historic district, and project recommendations (Table 4).

In the event that bones or prehistoric or historic archaeological materials are uncovered during construction or earth-disturbing activities, work in the vicinity should cease immediately. Any remains should be protected from further disturbance and qualified archaeologists should be notified. If bones are found, Bohannon-Huston will immediately notify local law enforcement and the Office of the Medical

Investigator pursuant to 18-6-11.2C (Cultural Properties Act NMSA 1978). In accordance with 18-6-11.2C and/or 36 CFR 800.13(b) (Protection of Historic Properties), Bohannon-Huston will notify the State Historic Preservation Officer (SHPO) or the State Archaeologist immediately. In either case, the SHPO will determine the necessary steps to evaluate significance, document, protect, or remove the material or remains, in compliance with the law. 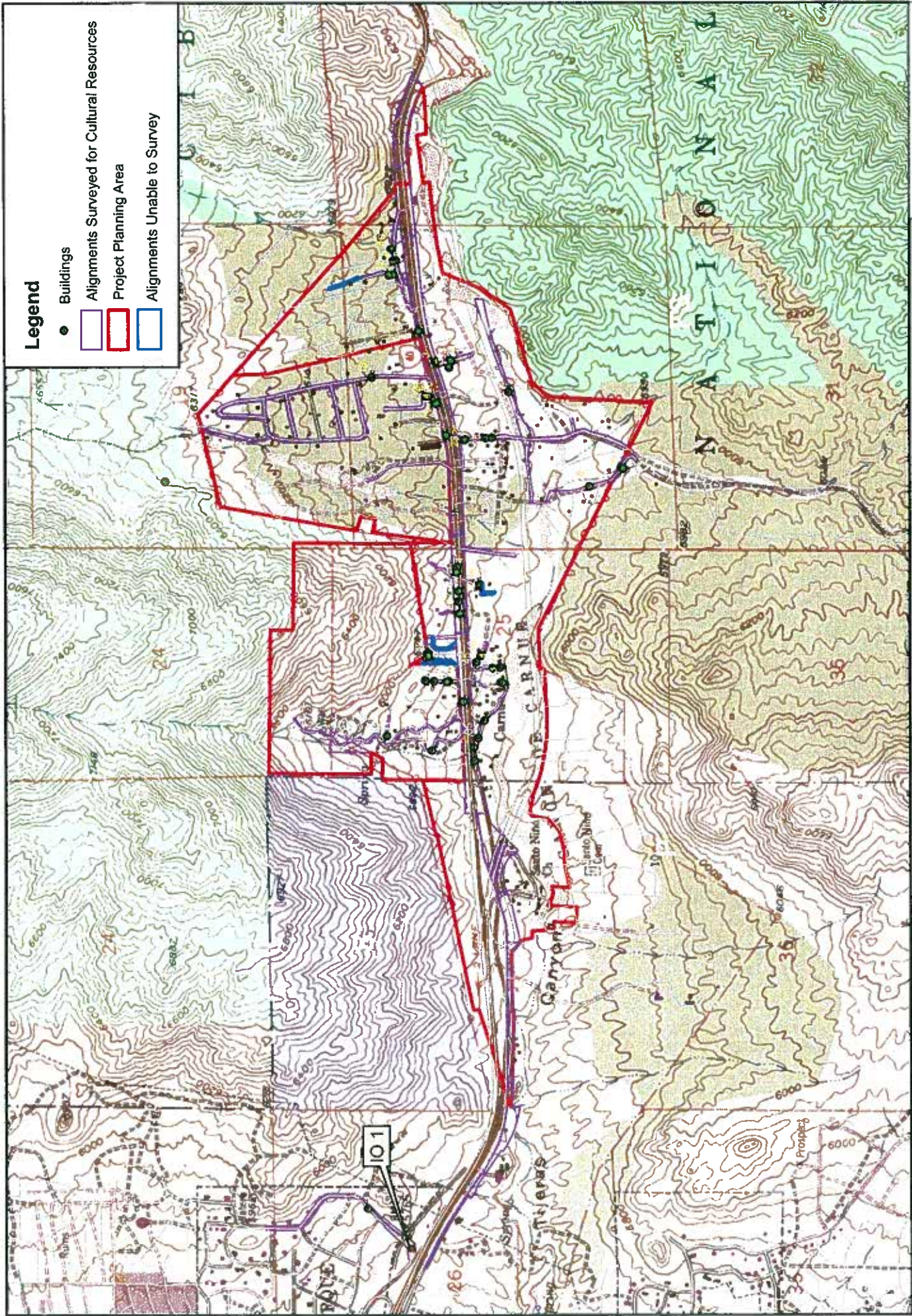
