Within three business days of awarding an emergency procurement Contract, the Central Purchasing Office shall post on its web site this notice of the Emergency Purchase. Requisition for purchase must be completed and attached.

1. Date Emergency situation first noted/occurred (time and date):

Operations Group first encountered plant alarms and shutdown on September 28, 2024. Central Engineering was notified of the emergency issue on October 2, 2024 at 2:30pm.

2. Describe emergency situation – Be very specific (attach additional pages, if required):

College Arsenic Treatment Facility (ATF) has a 30,000-gallon raw water storage tank located upstream of the ATF. This steel storage tank is part of the ATF and is feeding raw groundwater to the plant.

The SJC Plant Operations group first encountered plant alarms on September 28, 2024. The ATF membranes were fouling and causing the plant to shut down due to excessive differential pressures. The Plant Operations and Groundwater Operations groups checked the feed wells and upstream pump station, but no sand or water quality issues were observed. The College ATF on-site storage tank was emptied, and a dry inspection was performed by Operations on October 2, 2024. It was determined that the coating inside the tank has completely failed. Debris accumulation was observed inside the tank. Photos from the dry inspection are included below.

The debris and rust chipping off from the tank were entering the ATF and causing excessive fouling of the membranes. The Operations took the College ATF off-line on October 2, 2024 to protect the membranes and prevent complete failure of this asset. A second dry inspection was performed by Operations and D&R Tank on October 3, 2024 at 11:30am. Repairs to the storage tank are needed before the College ATF can be put back on line.

3. Impact/consequences had purchase not been made immediately:

The College ATF is critical to westside water supply. We are still in high-demand season, and the College ATF was planned to be in operation to provide the necessary supply. Due to other well rehab projects and well outages, current groundwater well production capacity is only 118 MGD, with current system demands ranging between 90 and 100 MGD, which is an uncomfortable level of "buffer" supply available for the water system. Getting the College ATF back in production after coatings repair of the storage tank is critical for reliable water supply.

4. Item(s) purchased:

All labor, materials, and supervision to field paint and chlorinate one 30,000-gallon welded steel water storage tank, including:

- Record drawings
- Interior and exterior painting system
- Sika Flex interior roof
- Independent NACE inspection
- Disinfection of tank upon completion of work
- One year warranty including 11-month inspection with tank empty and out of service
- Price:

\$87.324.51

The total cost for interior and exterior cleaning and repair is \$70,887 without NMGRT. See attached quote from D&R Tank.

D&R Tank is the original vendor that supplied the existing tank and is the Water Authority's trusted vendor for steel reservoir and tank coatings. Due to the time constraints with this emergency, only D&R Tank was contacted for a quote.
